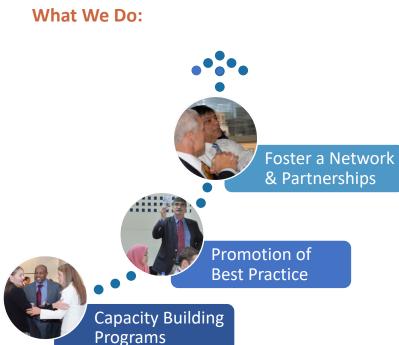

- » Founded in 1909 in Helsinki, Finland; mainly state funded
- » GBSN member as of 2018
- » Triple accredited: EQUIS, AACSB and AMBA
- » PRME member as of 2008
- » Ranked by Financial Times, Among top10 in U-multirank, citations and research linkages
- » Only stand-alone university-level business school in Finland
 - » BSc, MSc and PhD programmes, and Executive MBA programme
 - » Languages of instruction: Swedish and English
 - » 5 academic departments and 1 language centre
 - » 2500 students
 - » 130 faculty, 100 staff





Executive Education



- » Hanken Executive MBA
 - » Two-year, part time programme with 25 modules within strategy, marketing, finance, accounting and leadership.
- » Hanken Executive Education Vaasa
 - » Executive education and development programmes mainly for SMEs in Ostrobothnia
- » Hanken & SSE Executive Education
 - » Customised in-company programmes within leadership, finance and accounting, as well as sales and marketing.
 - » Consortium programmes for groups of companies
- » Competence centres
 - » Programmes and seminars



Research at Hanken



- » The research conducted is internationally recognized
 - » Academy of Finland data on the impact of research conducted by Finnish universities (State of Scientific Research) gives Hanken an index value of 1.4 compared to the world average of 1.
 - » Top 10 index, which measures an university's share of the most frequently quoted 10% of publications in each field of research where it is active. Hanken's index value is 1.7, again compared to a world average of 1.
- » Two thirds of the articles published in international peer-reviewed scholarly journals are co-authored with scholars from abroad.

Hanken Premium Scholarships



Two Premium Scholarships for GBSN High Potential from Developing countries

- » Offered to students currently studying at or alumni of GBSN member schools from developing countries who apply to and are accepted into **Hanken's 2-year Master's Degree program** in the 2019-2020 academic year
- » Successful candidates receive the Premium Scholarship, which covers
 - » full tuition fee for two years (equivalent to 12500 EUR/year), and
 - » 8000 EUR/year for living expenses
- » Scholarships awarded based on the applicant's academic excellence

Hanken's Master's Programme in a nutshell



- » two-year leadership and business program taught in English
- » studies start in September 2019
- » you can choose a specialisation track
- » you are strongly encouraged to go abroad on an exchange. You get an additional scholarship for the exchange
- $\, \ast \,$ when you have completed the Master's Degree you will have
 - » a higher education degree in which you have gained a thorough knowledge of your major subject or specialisation from an academic point of view, and
 - » gained relevant skills for your future career.

- » Hanken alumni are well-placed on the job market world-wide
- » 95 % of our alumni are employed within 3 months after graduation
- » the studies prepare you for a future career in e.g. financial advisory or management, consulting, auditing, industry, media, public administration or non-profit organisations
- » you are well-equipped to continue with PhD studies in Finland or elsewhere in the world at leading business schools.
